Call to Order:

- Ballots distributed to congregation

Financial Review:

Dawn Jacobson provided 2024 financial review and 2025 budget overview

- 2024 Financial Review
 - o Income: \$77k ahead of budget, 18% ahead of plan
 - o Benevolence: Increase of 50% with \$49k given
 - Page 22 shows where the money was distributed
 - Staff and facilities slightly favorable
 - Net operating income \$81k favorable
 - Restricted reserve: \$16,810 for 2026 future technology and \$1,000 Dedicated Technology
 - Remaining net income to Facilities Fund Reserve
 - \$400k of the \$635k in restricted funds was invested in CDs resulting in \$25k interest for the year

- 2025 Budget
 - Operating budget of \$477K
 - o Benevolence: anticipate 4% but will attempt to increase this if possible
 - o We are in a very good position for 2025 but will need to pay attention to spend
 - 2025 budget approved with none opposed

Council President Comments: Tony Baumgardt

- Thank you to congregation for continued and increased giving; this allows us to give more to community and others; GOD IS GOOD
- There will be a survey coming out regarding our Mission and Vision process
- Recognized and congratulated Zeke Petrach for attaining Eagle Scout designation
